This is to report that upon instructions received our inspectors have supervised the loading of a parcel described as “CHICK PEAS IN BULK” into containers with Nos. as indicated above at “BSSS” Terminal, Kievskoe settlement.

**QUALITY:**

A composite sample representing the whole parcel of 36 containers proportionally mixed was submitted for analysis in SGS Novorossiysk laboratory and we report the average actual results as follows:

\*\*Grain admixture considered as seeds typical of the species but of another variety as per ISO 605
